Registration and fee are **DUE AUGUST 1<sup>ST</sup>, 2017!**

**BOOTH FEE:** Lisbon and Mt. Vernon Resident Vendors: \$100 pre-payment for a 10'x20' booth.  
Non-Resident Vendors: \$200 pre-payment for a 10'x20' booth.  
Any booth over allowed size will be charges \$5.00 per square foot.

**BOOTH SCHEDULE:** Festival setup begins the evening of Thursday August 10, 2017. All booth vendors must be setup and ready to serve customers by 4:00 pm Friday, August 11<sup>th</sup>, 2016.

**Booths must operate Friday August 11<sup>th</sup> 4:00-9:00pm and Saturday August 12<sup>th</sup> 11:00am-9:00 pm.**

(Booths may stay open no later than midnight, if necessary.) No early tear-downs or alternative schedules allowed unless approved by the committee. Tear-down must be complete by Sunday, August 13<sup>th</sup>, 9:00am. Lisbon Sauerkraut Days Committee(LSDC) has the right to charge vendor a \$100.00 cleanup fee. **FOOD VENDORS:** If serving food, vendor must have a food permit from the Linn County Health Dept. You can obtain a Temporary Food Service Permit from [www.sauerkrautdays.com](http://www.sauerkrautdays.com). Permits must be submitted to the Linn County Health Department prior to the event.

**The LSDC has exclusive rights on sauerkraut, hot dogs, brats, ruebens, cotton candy, funnel cake, and lemonade!**

**BOOTH LOCATION:** The festival is located downtown Lisbon along Main Street. LSDC will designate the booth setup space.

**BOOTH ELECTRICAL:** Vendor must provide extension cords. For safety reasons, no electrical cords will be allowed to run across sidewalks. LSDC has the right to limit electrical usage and is not responsible if cords do not meet electrical code. For electrical questions, please contact Vendor Support at (319) 361-3015.

**BOOTH CANCELLATION POLICY:** No refund unless cancellation is submitted in writing 30 days prior to the event to the address below. There are no rain dates.

**VENDOR PARKING:** No parking allowed on Main Street, North or South Washington Street except while loading or unloading. All vehicles must be off the streets at the time of the event. All vendor parking, including trailers **must use the Lisbon School north parking lot**. LSDC is not responsible for any damages to vehicles or equipment.

**VENDOR EQUIPMENT/MERCHANDISE/INSURANCE:** Each participant is responsible for handling and care of booth equipment, including protection from inclement weather. The LSDC accepts no responsibility for damage that may occur to equipment, including weather related damage. Flea Market Items: All merchandise **MUST** be approved by LSDC. LSDC has the right to limit sales. Provide copy of proof of insurance upon booth registration.
